### Open discussion:

- NDA measurement issues that affect process analysis for the criticality safety analysis. This was not discussed.
- Site fire department personnel taking CS training.
  - O Jeff Petraglia at SNL discussed recent integration of the Kirtland Air Force Base (KAFB) as the firefighters in the emergency response as the Incident Commanders (IC). SNL EM is no longer the IC as of 2021 and supports the KAFB IC. This change was due to a graded approach application of ANS-8.23 for emergency response. Firefighters are training on how to respond to a fire involving fissile materials, especially where water can be used and the one location where water should only be used after consulting with criticality safety.
  - Cheryl Arm at PNNL discussed the recent emergency response drill. Unfortunately, CS was sideline and there was a lot of confusion concerning medical attention. One person who was at the source of the accident was never found even after 3 hours. The element of interface was LTA. The group had many questions on how to integrate criticality safety.
  - o Tammy Wise talked about Navy shipyard experience.
  - After the call, Jeff Petraglia and Chery Arm talked about lessons learned from the last 2
    years of drills. Currently the SNL criticality safety engineers train the KAFB firefighters.
